

I just learned about the Nov. 12th deadline for this extremely crucial so called diagnosis on my **mental state** of being concerning a 3 year old email dispute between myself and somebody I never met 1000 miles away from my home nobody was witness to me sending. I'm happy that I'm **competent** and remember John L. Sinatra Jr. saying in court on July 30th something along the lines of "Even if he is diagnosed as mentally retarded, has AIDS, and lobotomized into an incompetent vegetable, the defendant has a right to testify". The stenographer is liable to have edited the court notes concerning what he said, but it was something along those lines. I'm happy I'm **competent** and remember Frank Passafiume telling me at the end of January 2024 "let's end probation", I remember officers at **Orleans County Jail** telling me "your defense lawyer would not have said that to you if he didn't speak to other members of the court first", and I remember John L. Sinatra Jr. saying on July 30th "we can just waive all further steps you guys". I inherit my father [REDACTED]'s memory capabilities.

Due to the fact that I am extremely **competent** of all remaining bureaucratic procedures for this infraction, I would like to state my intentions to Plea **The Fifth** and my right to remain silent if there are any more **psychiatric interrogations** **Orleans County Jail** but for these circumstances **Orleans County Jail** is enough and I know you all agree.

I am sending this out on Oct. 31st as we are all wearing pumpkin orange and feeling very festive here at the **Chicago Metropolitan Correction Center**. Will I be able to vote this year? I have given this court ample notice about my desire for at bare minimum an early voting absentee ballot. Frank told my father over email it would only take 30 days for me to be here, nope that clearly wasn't the case. My father had to get the license plates. My mother Janet McCaul of [redacted] in Little Valley NY [redacted] called NY State Troopers on that [redacted] NY redhead initials KV, but for some reason the grand theft auto charges never followed through. Did she have an affair with that NY State Trooper? I'm glad my second cousin Chris Giardini Jr. just became a NY State Trooper so he can help look into this. I've left a voicemail on Frank's phone concerning my desire to press federal charges equivalent to grand theft auto on this woman if it's still possible. She lied about Frank earlier this year, on top of the fact that a defense lawyer I never met did this to me. I would think that Frank would be interested in helping pursue these types of charges against her.
